# **CARRY-ON ACCOMPANIED BAGGAGE**

In force from the 1<sup>st</sup> April 2016

# **CARRY-ON BAGGAGE – DEFINITION**

- Accompanied baggage is considered to be baggage following the passenger whose cargo he/she provides, any transhipment, unloading and custody during transport, exempting this Navigation from any responsibility in this regard.
- The transport of potentially dangerous material is not allowed.

# **MOTORSHIPS AND FERRIES ORDINARY SERVICE**

- Any special baggage that exceeds the linear dimensions of normal baggage, but not the weight, may be transported provided that they do not cause obstruction to the service compatibly with the spaces available on board and at the sole discretion of the Captain.
- The transit of bicycles, tandems or bicycles with trailers, on ferryboats, when these carry out the service of transporting vehicles by connecting the boarding piers vehicles of two ports of call, are not considered luggage, but vehicles and taxed <u>accordingly</u>.
- The boarding of bicycles is conditioned by the type of motorship and by the incoming traffic. The Captain can limit the number of bicycles to embark in case their transport would compromise the service.
- Scooters and pedal-assisted electric bicycles are considered bicycles.

### HYDROFOILS AND CATAMARANS SPEED SERVICE

• Accompanied luggage, with a major side greater than 0.60 m, bicycles and goods in general are not allowed to be transported on hydrofoils and catamarans.

### **BAGGAGE RULES AND TAXATION**

- Each passenger may carry free of charge only one piece of baggage that does not exceed the following measures: major side not exceeding m. 0.60 volume not exceeding dmc 40 and weight not exceeding kg. 20.00.
- Scooters and folding bicycles if folded on themselves and with a maximum length of less than 1.10 m do not pay, if opened or if they exceed the above length they pay the same rate as bicycles.
- All accompanied baggage that exceeds the linear measurements and all baggage after the first one regardless of the measurements are subject, for each single unit, to the payment of the following rates:
